Sub: Constitution of Inspection teams for the purpose of reimbursement of eligible units in terms of SRO-519, SRO-521 dated 21.12.2017. SRO-63 dated 05.02.2018 and SRO-431 dated 25.09.2018.

ORDER

In Exercise of powers vested in me under clause 4.1 of SRO-519, SRO-521 dated 21.12.2017, SRO-63 dated 05.02.2018 and SRO 431 dated 25.09.2018 and on supersession of all previous orders issued on the subject, teams under the leadership of below mentioned officers with jurisdiction shown against each is constituted for the purpose of inspection in case of eligible units for claiming of reimbursement of GST as per the government notifications mentioned above.

Each inspecting team shall comprise of two (02) State Taxes officers and two (02) Inspectors to be nominated by the Additional Commissioner State Taxes (Administration and Enforcement) of the concerned divisions for a period of one quarter on rotational basis. It is important to note that the inspection of the eligible units is to be carried out in terms of various clauses of SRO 519, SRO 521, Dated 21-12-2017, SRO 63 Dated 05-02-2018 and SRO 431 Dated 25-09-2018 for all the claims pending from first quarter 2023-24. The claims shall exclusively be received and disposed off online only.

Also, the cases of previous year assigned to the officers / officials shall be concluded by the concerned officers by or before 30th August 2023 positively.
