Creation/Abolition/up-gradation of following posts in the
State Taxes Department:

A) Creation of the following posts in the State Taxes Department:-

- (i) Four (04) posts of Deputy Commissioner, State Taxes, Enforcement in the Pay scale of Rs. 15600-39100 Grade Pay (7600) (pre-revised) with the following areas of jurisdiction:-
 - a) Deputy Commissioner, State Taxes, Enforcement (South), Kashmir, catering to districts of Anantnag, Kulgam, Shopian, Pulwama, headquartered at Lower Munda.
 - b) Deputy Commissioner, State Taxes, Enforcement (North), Kashmir, catering to districts of Baramulla, Bandipora, Kupwara, Sopore headquartered at Sopore.
 - c) Deputy Commissioner, State Taxes, Enforcement (Samba), Jammu, catering to districts of Samba, Rajouri, and Poonch headquartered at Samba.
 - d) Deputy Commissioner, State Taxes, Enforcement (North), Jammu catering to districts of Udhampur, Reasi, Ramban, Doda, Kishtwar headquartered at Udhampur.
- (ii) One (01) post of Assistant Commissioner, State Taxes (Technical) in the Pay scale of Rs. 15600-39100 Grade Pay 6600 (pre-revised) in the Commissionerate office.
- (iii) Four (04) posts of System Analyst in the pay scale of Rs. 15600-39100 Grade Pay 6600 (pre-revised) in the ICT Governance Wing of State Taxes Department.

The Information Technology Department, J&K shall provide the above staff for ICT Governance Cell.
- (iv) One (01) post of Estates Officer in the Pay scale of Rs. 15600-39100 Grade Pay 6600 (pre-revised) in the Commissionerate office.
- (v) Fourteen (14) posts of State Taxes Officer in the pay scale of Rs. 9300-34800 Grade Pay 4800 (pre-revised).
- (vi) Two (02) posts of Administrative Officer in the pay scale of Rs. 9300-34800 Grade Pay 4800 (pre-revised).
- (vii) One (01) post of Accounts Officer in the pay scale of pay scale of 9300-34800 Grade Pay 4800 (pre-revised) in the Commissionerate office.


- (viii) Six (06) posts of Senior Stenographer in the Pay scale of Rs. 9300-34800 Grade Pay 4600 (pre-revised).
- (ix) Eleven (11) posts of Cashier in the Pay scale of Rs. 9300-34800 Grade Pay 4200 (pre-revised).
- (x) Twenty seven (27) posts of Driver in the Pay scale of Rs. 5200-20200 Grade Pay 1300 (pre-revised).
- (xi) One hundred and forty eight (148) posts of Orderlies by corresponding reduction of equal number of Posts of Process Servers. This creation shall take place in a staggered manner as and when the vacancies accrue in the cadre of Process Servers due to retirement, promotions, resignations or death or any other reason. The incumbent process servers shall continue to function on the existing posts till they vacate the posts in the above manner upon which these posts shall be deemed to have been included to the cadre of orderly.

B. Abolition of the following posts in the State Taxes Department:-

- (i) One (01) post of Additional Commissioner, Commercial Taxes, Headquarter, SIU in the pay scale of Rs. 37,400-67,000 with grade Pay of Rs. 8700 (pre-revised).
- (ii) Twenty eight (28) posts of Inspector in the pay scale of Rs. 9300-34800 Grade Pay 4200 (pre-revised).
- (iii) Four (04) posts of Head Guard in the Pay scale of Rs. 5200-20200 Grade Pay 1900 (pre-revised).
- (iv) One (01) post of Jamadar in the Pay scale of Rs. 4440-7440 Grade Pay 1400 (pre-revised).
- (v) One hundred and forty eight (148) posts of Process Servers in phased manner.

C. Up-gradation/transition of the following posts:-

- (i) Six (06) posts of Audit Supervisors & two (2) posts of Stamp Supervisors as Section Officers.
- (ii) Fourteen (14) Posts of Assistant Audit Supervisors as Cashiers.
- (iii) Sixteen (16) Posts of Auditors as Senior Assistants.




