- Academic Qualification Certificate.
- Matriculation/ Date of Birth Certificate.
- Health Certificate issued by Chief Medical Officer.
- Domicile Certificate issued by the Competent Authority
- Certificate from the concerned authorities to the effect that no loan under self-employment scheme has been taken by the appointee concerned.
- Certificate of belonging to the reserved Category, wherever applicable.
- Migrant Registration Certificate
- Migrant Registration Certificate issued by Competent Authority
- Undertaking in prescribed format as communicated by CID vide communication(s) referred to above

The appointment of the above candidates shall further be subject to the following conditions that:-

- Each appointee shall execute an agreement in the "Form" prescribed under Jammu and Kashmir Migrant (Special Drive) Recruitment Rules, 2009, issued under notification SRO 412 of 2009 dated 30.12.2009.
- Each appointee shall give an undertaking duly attested by First Class Magistrate in the shape of an affidavit to the effect that in case an adverse report about his Academic/Technical/Category (if any)

- certificate(s) is received from concerned issuing agencies, he/she have no right to claim his/her appointment as Sub-Inspector and as such shall be deemed to have been cancelled **ab-initio**
3. If on verification, the certificate(s) produced by the appointee are proved to be fake or forged, the appointment shall be cancelled **ab-initio**.
 4. The salary of these appointees shall not be drawn and disbursed to him until and unless satisfactory report about genuineness of their academic/technical/registration certificates is received from the concerned quarters.
 5. The appointees shall be on probation for a period of 02 years during which they shall have to qualify the departmental examination (Excise & Taxation Part-I Departmental Examination).
 6. The appointment of candidates shall be governed by the "New Pension Scheme" as per SO 400 of 2009 Dated: 24.12.2009.
 7. The fixation pay and allowances and the conditions of probation of the appointee shall be governed in terms of SO 194 dated: 17.06.2020 as provided under Government order No 586-JK(GAD) of 2021 dated: 07-07-2021
 8. The inter-se-seniority of the appointees shall be in the order of merit of the Selection List issued by J&K Service Selection Board vide No. SSB/Sel/Secy/M/02/2021/6307-13 dated: 23-09-2021
 9. The appointment is subject to outcome of any writ petition(s) pending in any court of law of the competent jurisdiction and verification report from the Relief Rehabilitation Commissioner, Migrant for Migrant/Category/Domicile certificates of the appointees.

The appointees shall report before **Addl. Commissioner State Taxes (Administration & Enforcement) Kashmir** within a period of 21 days from the date of issuance of this appointment order. In case the appointee fails to join within the stipulated period, his/her appointment shall be deemed to have been cancelled **ab-initio** without any further notice.
